

**[Latitude League Sweepstakes]
Official Rules**

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **Eligibility:** The Sweepstakes is open only to Latitude League members who are legal residents of the United States and Canada (excluding Quebec) and are at least 18 years (19 years in AL, DE and NE; 21 years in MS) or age of majority whichever is older in State of Residence, at the date of entry into Sweepstakes. Nevertheless, the following individuals are not eligible to enter: (a) employees of Dell Inc. 3. **Drawing:** At approximately 12:00PM on 2/10/2021, Sponsor will select 10 potential winner(s) in a random drawing of all entries received. The odds of being selected depend on the number of entries received. **The winner(s) will be announced publicly within 30 days of the Contest end date.** A winner will be required to sign an Affidavit of Eligibility and Liability, and a W9 form (for prizes exceeding \$600 USD in retail value) to claim their prize.
